Rules & Regulations

Safety & Build Rules

1. Any enclosed power wheels are allowed (no 4-wheeler or motorcycle type).
2. Child's legs must be in the vehicle compartment and fit.
3. Helmets must be worn; bicycle helmets are ok.
4. The vehicle is allowed to have a 6- or 12-volt battery.
 - a. The stock battery may be replaced with a lawn mower battery but must be sealed away from the child (not on passenger seat).
5. All doors and tailgates must be strapped shut. No sharp edges. Use zip ties, duct tape, or other flexible products to make them stay shut.
6. Tires may be covered in duct tape to keep them from breaking.
7. Motor must remain stock.
8. Raising, lifting, or modifying the vehicle other than the battery is not allowed.

General Race Rules

1. Only 1 parent/guardian will be allowed on the track for race preparation and flagging.
2. 4 balloons will be fixed on the vehicle (1 per corner), the object is to pop the other racers balloons without having yours popped.
